**The following is the Financial Position of our Society.**

Admission collection - Rs. 2.854 crores

Fixed Deposits in SBI --2.75 Crores. S/B A.c Rs.500000.00

We are to collect the amount paid to the nominees of Dr. Srirama Krishna Rao Rs.11,20,500.00 and the amount to pay for the nominees of Dr.Noel Moniz Rs.11,59,500.00 which we have to pay in our FC IV dues letter.

FC I dues are 18 Members FC II Dues are 12 members FC III Dues are 317 members total dues 2.5 lakhs.

Total fund in the account of FBS AIOS as on 31-3-09 is 2.94 crores.

Since we could not get the 12(a) in the usual method we applied again to the IT Dept under "Mutual Beneficiary clubs" quoting various Court judgments in India and our auditors are hopeful to get the 12(a) and if we get it we will also get back the tax of 6.5. lakhs we paid already .we got the Income tax approved assessment order up to March 2008.
